



## Top Tips to Avoid Non-Conformance Red Tractor Combinable Crops and Sugar Beet

Is your Integrated Pest Management Plan (IPM) complete?</p> <p><b>You can complete it online here:</b> <a href="http://www.nfuonline.com/ipm-plan/">http://www.nfuonline.com/ipm-plan/</a></p>	<p>2. <b>Always</b> dispose of waste in a manner which prevents contamination and pollution.</p> <p><b>Often overlooked:</b></p> <ul style="list-style-type: none"><li>- No receipts/ waste transfer notes to show assessor.</li></ul>
<p>3. Has your PPP equipment being appropriately tested and all certificates are in date?</p>	<p>4. Make sure you and contractors you use are NRoSO members.</p> <p><b>Often overlooked:</b></p> <ul style="list-style-type: none"><li>- Keep a record of membership numbers and expiry dates for yourself and contractors on file.</li></ul>
<p>5. If your stores are looking a bit tired and run down, have a think about how you can improve them.</p> <p><b>Look out for:</b></p> <ul style="list-style-type: none"><li>- Loose flooring;</li><li>- Is it rodent and bird proof?</li><li>- Bitumen must not be used for new floors or filler.</li></ul>	<p>6. Ensure storage conditions do not compromise crop quality by monitoring and keeping records of the crop in store.</p> <p><b>Often overlooked:</b></p> <ul style="list-style-type: none"><li>- Temperature;</li><li>- Date of checks;</li><li>- Follow up actions</li></ul>
<p>7. Have you carried out a risk assessment for both temporary and long-term stores?</p> <p><b>Often overlooked:</b></p> <ul style="list-style-type: none"><li>- CIPC risk assessment and corrective actions.</li></ul>	<p>8. Don't forget to include a Mycotoxin Risk Assessment for current growing season.</p> <p><b>Ensure you include:</b></p> <ul style="list-style-type: none"><li>- Each wheat field or block of fields containing the same variety.</li></ul>
<p>9. Keep <b>complete</b> records from insect traps in stored grain.</p> <p><b>Often overlooked:</b></p> <ul style="list-style-type: none"><li>- Dates of checks;<ul style="list-style-type: none"><li>- Insect activity;</li></ul></li><li>- Follow-up actions.</li></ul>
