#### IS LRQA (PREVIOUSLY KNOWN AS ACOURA) YOUR CERTIFICATION BODY?

If LRQA is your certification body, we have recently let you know that there is a change in their business strategy which means they will not be delivering Red Tractor farm scheme certification next year. If you are currently certified by LRQA, you will need to transfer your membership to another one of our certification bodies. **CLICK HERE** for more information about this process.

Remember that temporary storage must not be used after the 31 October. As temporary stores aren't sealed, they are not weather or vermin proof, so from this date grain must be either moved into a long-term store, or into a central store or be sold to
